



## Introduction

The GROWashington-Aroostook regional planning initiative was launched in June of 2012 at a large stakeholders meeting in collaboration with the start of the Mobilize Maine Downeast economic development planning process.

Mobilize Maine is a partnership between Vital Economy and the seven economic development districts (EDDs) in Maine, each of which are developing strategies based on their region's indigenous assets. The Mobilize Maine process, underway in Aroostook County since 2009, was linked with Washington County when the Eastern Maine EDD changed in 2011 and shifted Washington County from an association with the Eastern Maine EDD (with Eastern Maine Development Corporation in Bangor) to the Aroostook-Washington EDD (with the Northern Maine Development Commission in Caribou).

A primary first step for both the GROWashington-Aroostook and the Mobilize Maine planning processes was to create a vision for the region. As the goals of both processes are similar in multiple respects they share a single vision.

Over the course of several "asset-mapping" meetings in the fall and early winter of 2012, stakeholders developed ***the following vision for the Aroostook-Washington Economic Development District:***

*Our region is a place of abundant natural resources that is reflected in the beauty of our landscape and the potential for economic and social prosperity it offers. We value the individuality and endurance of our people while recognizing the strong sense of community and place that sustains us. We will create economic growth by focusing on sectors that best leverage these assets and by working to develop policies that promote private sector investment; while at the same time, retaining the quality of life that makes the region special.*

## Outreach and Communications

Each Work Plan Component (<http://www.gro-wa.org/plan-components.htm>) in GROWashington-Aroostook created Work Teams (<http://www.gro-wa.org/workgroups.htm>) composed of staff, partner agencies and stakeholders.

As with the work products themselves, the type of community input varied across subject areas. Some input followed a traditional work team series of meetings that contributed to the production of a final report, for example in the creation of the Regional Plan for Sustainable Housing in Washington County. Other areas were more dependent



on staff and technical expertise to generate work products and then outreach meetings to gather input and refine the product, for example in the Climate Vulnerability Assessments in Washington County (<http://www.gro-wa.org/climate-vulnerability-assessment>) and the water systems assessments in both counties (<http://www.gro-wa.org/specific-water-systems-analysis>). Still others culminated in summit gatherings where over a hundred stakeholders came together to learn, network and share innovations and ideas, for example the November, 2013 Downeast Transportation summit (<http://www.gro-wa.org/downeast-acadia-transportation-summit>), the Washington County Local Food outreach meetings in April and May of 2013 (<http://www.gro-wa.org/food-system-meetings>), and the March, 2014 Washington County Food Summit (<http://www.gro-wa.org/washington-county-food-summit>).

In addition the GROWashington-Aroostook Facebook page provided announcements from time to time of public meetings and the web site provided an opportunity for input throughout the process.

Finally a request for input on the entire project was released in “Local Happenings”, an e-news service provided by the Sunrise County Economic Council, in April of 2014. All comments received were incorporated into final work plan products.
